EV34/20 Committee to note update for December to Remember.

Administrative Assistant advised the event had been very successful, receiving many positive comments via email and on social media. There were over 109 entries and over 300 votes. The first place winners were Wilf's Wonderland. No.21, organized by Wilf's Ward family trust, second place winners were Festive Fernland, No. 66, the street who did Fernland Close together and third place winners were Enchanted Forest, No. 52.

RESOLVED: Committee noted the update and unanimously agreed they were pleased with the success of the event.

## EV35/20 Council to discuss and propose a schedule of events for 2021, based around events that can be completed with social distancing in mind, but expanded if restrictions are lifted.

Cllr Bentley suggested after the success of the Scared-Crow weekend and the December to Remember event that these remains as scheduled events for 2021, in which committee agreed.

Cllr Bentley asked if any committee members had any ideas for a Spring and Summer event. Committee discussed the possibility of holding an Easter event and it was agreed to start planning for an Easter Egg hunt over the Easter long weekend. Committee discussed the possibility of hiding wooden Easter eggs around an area in the community, in which each egg could display a word, ultimately creating an Easter verse. Committee discussed the possibility of having 15 eggs for children and families to search for but resolved finer details could be confirmed closer to the event, depending on the social distancing regulations in place at the time

Committee discussed the potential for a Summer Fair but resolved to defer this decision until the next meeting when social distancing regulations will be clearer.

RESOLVED: Council resolved to proceed with the Scared-Crow Weekend and the December to Remember event for 2021. Council also resolved to proceed with planning of an Easter Egg hunt for 2021, deciding on finer details closer to the event depending on social distancing regulations. Council also resolved to defer the decision of a summer event until the next meeting when social distancing regulations will be clearer.
