**EV37/20 Roll Call of Councillors, Officer and members of the public present – Record Confirmed.**

**RESOLVED: Council roll call of Councillors and Officers present record confirmed.**

**EV38/20 To accept apologies**  
No apologies received.

**EV39/20 To accept Declarations of Interest relating to items on the agenda.**  
No declarations of interest received.

**EV40/20 To confirm as a correct record the minutes of the Events and Publicity Meeting held on 12<sup>th</sup> January 2021.**  
Cllr Brogden proposed, seconded by Cllr Rowe, that an amendment be made to the attendance records on the minutes and Cllr Muzaffar be removed. Upon completion of amendment Committee accepts the minutes as a true and accurate record of the meeting.

**RESOLVED: Committee resolved to approve the minutes as a true and accurate record once the Members Present section has been altered to reflect Cllr Muzaffar was not in attendance.**

**EV41/20 Committee to approve the rhyme for the Easter Egg Hunt.**  
Cllr Brogden proposed, seconded by Cllr Bentley and agreed unanimously to approve the use the rhyme proposed.

**RESOLVED: Committee resolved to approve the use of the proposed rhyme in the Easter Egg Hunt.**

**EV42/20 Committee to consider the authorisation to purchase 12 large MDF easter eggs and signs at £80.**

Proposed by Cllr Brogden, seconded by Cllr Luckraft and agreed unanimously that the Council purchase MDF Easter eggs and signs for the Easter Egg Hunt.

**RESOLVED: Committee resolved to purchase 12 MDF Easter eggs and signs for the Easter Egg Hunt at a cost of £80.**

**EV43/20 Committee to consider the painting of Easter eggs at a cost of £300.**

Cllr Brogden proposed, seconded by Cllr Rowe that the Council approve the painting of the Easter eggs and signs at £300. Each egg will be uniquely painted with a word from the rhyme hidden in the egg. The word will be able to be altered each year, to make the eggs reusable.

**RESOLVED: Committee resolved to approve the painting of the Easter eggs and signs at a cost of £300.**

**EV44/20 Committee to consider the Easter Egg hunt is to take place for one day Saturday 3<sup>rd</sup> April 2021, with social distancing guidelines in mind.**

Committee agreed that a one-day event (from 10am -4pm) is the best way to proceed in terms of staffing the event. Cllrs volunteered to assist on the day with staff. Cllr Brogden offered the use of the Village Hall as a central location to end the hunt, with both indoor and outdoor space to receive the prizes. Cllrs agreed to purchase Easter Eggs as prizes.

**RESOLVED: Committee resolved to hold the Easter Egg hunt for one day, Saturday 3<sup>rd</sup> April 2021, 10am-4pm, to finish at the Village Hall where entrants will receive a prize of a small Easter Egg.**
