Committee presented with a draft version of the 2023/24 budget and held a robust discussion. It was agreed in principal that the precept should raise by 5% and that the budget lines seem appropriate. It is noted that the Tax Base has not yet been provided by East Riding of Yorkshire Council so the income is currently an estimated amount.

Committee also discussed the possibility of using £25,000 from property reserves to employ a Town Handyman and purchase the initial tools required to perform the role.

Proposed by Cllr S Duckles, seconded by Cllr Bentley and agreed unanimously to accept and recommend to Full Council the draft budget with a proposal to use £25,000 be taken from the property reserve funds in order to hire a Town Handyman for 16 hours and purchase initial tools and required equipment.
